2021 OPERATING PLAN

CAMPER & STAFF HEALTH PLAN

Camper Health

- Intake Screening and Assessment
 - Fill out a DSBC Screening & Baseline Form before loading on to transportation to head to camp DSBC Screening & Baseline Form will be turned in upon arrival for approval by the Camp Health Officer.
 - Campers will need to provide their own Personal Protection Equipment and additional sanitizer (sanitizer provided in public areas, soap and water provided in all cabins restrooms).
- Regular Screening and Assessment
 - Each day an adult leader from each church will conduct a health screening for each camper before breakfast. They will fill out the DSBC Daily Health Screening Form and turn this into the first aid station before breakfast. Daniel Springs will provide the form.
 - The camp will have a limited number of non-touch thermometers, but we are asking each church to bring at least one non-touch thermometers for the use of their group.
 - All forms will be turned into the Camp Health Officers and will become a part of the Camp Health Log.
- Preventing Spread
 - Handwashing and personal hygiene will be emphasized
 - Physical Distancing will be emphasized. Anywhere large groups gather, separation will be facilitated (lines in dining hall, tables separated, worship center seating separated)
 - Guidelines from the state strongly encourage masks to be worn when you are within 6 feet of anyone not in your household.
 - Camper visitors will not be allowed on camp. The state guidelines define it clearly, "No visitors to the camp unless necessary for camp operations, such as food delivery."
- Response and Management of Case(s) or Probable Case(s)
 - Camp management will work with the Camp Health Officer to determine course of action.

- Anyone with symptoms of illness, in particular Covid-19, will be isolated and parents will be contacted to pick them up.
- Cleaning of the area in which the sick camper slept will be done by camp staff. If possible, the group staying with that camper will be moved to a new lodging area.
- As Daniel Springs Camp is not a medical facility, on-site testing will not take place. Rather we will refer anyone suspected of having Covid-19 to their local health care facility.
- A letter will be given to all group leaders for distribution to camper families to discuss possible post-camp protocols.
- Even if there is no suspected case, for up to 14 days after camp, a parent may want to limit their camper's access to anyone who would be in the higher risk category (immunosuppressed, age 65 or older, etc.)
- Health Center and Sick Person Isolation Area
 - The Health Center will be the primary site for medical concerns. Isolation space will be provided for temporary housing of ill campers. The best location of this isolation area will be determined by the camp management and the Camp Health Officers.
- Staff Health
 - Staff will follow a similar plan as outlined above. Staff who operate in the food service areas or anytime they will be within six feet of campers will take additional precautions.

CABIN HYGIENE PLAN

<u>Housing</u>

- Churches partner with Daniel Springs and as such will be the frontline defense for cleanliness and hygiene in the cabins.
- Daniel Springs will house groups with social distancing in mind.

• Each group will assign bunking and communicate to sleep head to toe.

Common and Shared Spaces

- Churches will utilize their cabin as their common space.
- Large group meeting spaces (tabernacle, cafeteria, etc) will be cleaned at least once per day by Daniel Springs staff.

Cleaning and Sanitizing

 A Daniel Springs cleaning crew will be on hand each day of camp. They will clean and sanitize all public areas. They will check consumable products in all cabins. They will not be touching the camper's personal belongings. We ask that no personal items be left in the cabin restrooms.

DINING HYGIENE PLAN

Cafeteria Layout

- Self-serve Salad/fruit bars will be removed (salads and fruit options will be available)
- Campers will line up by their church group at their assigned time. Lines will be created so that social distancing between groups can be achieved.
- Cafeteria tables will be rearranged to support distancing. Extra seating will be available in the canteen area outside.
- Trash cans will be located at the exits to minimize lines to dispose of plates.

• Hand sanitizer stations will be in several areas in the dining hall. Soap dispensers will be in the public restrooms.

<u>Serving</u>

- All staff will wear masks, gloves, and hair restraints when preparing food, serving, or cleaning cafeteria.
- Meals will be served with disposable utensils, napkins, cups, and plates.
- Every food option for a meal will be served by staff including plates, napkins, utensils, main entree, sides, salads, fruit, cereal, desserts. Campers can elect to choose or deny some options at the lines. Additional staff will be available to quickly sanitize tables and chairs between campers if multiple meal times are needed to rotate campers into the cafeteria.

Cleaning

- All tables, beverage areas, and serving lines, will be sanitized after each meal. In addition, all high touch surfaces including door handles, vending machines, and all restroom surfaces will be sanitized
- Chemicals used are EPA approved for use in food service.

<u>Misc</u>

• Camper sponsors will be helpful to remind campers to wash/sanitize hands and practice distancing.

PROGRAM ACTIVITY PLAN General Guidelines for Recreational activities

- Recreational activities will have specific instructions (see additional steps taken in the Program Operation Plan) on sanitization and operation. In general:
 - Daniel Springs will ensure all stations, equipment and supplies are sanitized
 - All Ga-Ga pits and Nine-square sets will be placed in full sun locations. Balls will need to be checked out when the canteen is open
 - Sanitizer and disposable gloves will be available at recreation locations
 - Daniel Springs will provide a water station. This will be in the form of an igloo. Any igloo water station will be manned by a DSBC staff or adult volunteer with gloves to fill up camper water bottles or cups.
- Aquatics & Water-Related
 - COVID-19 cannot spread through pool water: https://www.cdc.gov/coronavirus/2019-ncov/php/water.html
 - Daniel Springs will provide life jackets at the waterfront for paddleboating. These will be dipped in a sanitation solution after each use and hung to dry. Campers may provide their own lifejacket, but these must be a U.S. Coast Guard approved wearable PFD. These should not be shared with other campers. DSBC will make final approval of any camper supplied lifejacket.

<u>Crafts</u>

• Crafts should be planned in such a way that supplies and tools are not shared.

• All tables, chairs, supplies and equipment should be sanitized between uses.

General Store

• Campers will visit the General Store in their free time. We will limit the number of campers who are in the gift shop at one time.
